You must own a Corvette. 2. You cannot belong to any other Colorado Corvette club. 3. You are required to attend one business meeting and one event over a consecutive 3-month time period. There is usually one event monthly AND the Business Meeting is held on the 1st Tuesday of each month. Any club officer of LGCA can tell you when/where the next event/meeting will take place. 4. Completion of this application and submittal to the LGCA Membership 	<p>Chairperson initiates the membership process.</p> <ol style="list-style-type: none"> 5. When you attend at least one (1) Business meeting and one (1) LGCA Event, you are eligible for membership into LGCA. 6. All members must be 'voted in' at a Business Meeting, and approved by members present. 7. Following approval, you must pay an initiation fee of \$10 AND membership dues within 30 days of being voted into LGCA. Club dues are \$5 per month/per membership. Dues are payable from current month through December.
